Welcome to Tbilisi and this conference!

Recent history has seen fundamental regional changes within the emerging political spaces of the former Soviet Union. State borders have been redefined in terms of national sovereignty, as frames for free and sovereign action, but they have becomes sites of hardening, closure and, perhaps most seriously, of territorial conflict. We see fragmented visa regimes as well as new migration patterns oriented both towards Russia and the European Union. At the same time, the forces of change that impact on the Caucasus and other Post-Soviet spaces also involve a differentiated exposure to globalization and rapid technological change. Furthermore, an internationalization of the overall regional political context has taken place; Russia, the European Union, NATO, Turkey and other actors have taken an increasing interest in energy-related and other strategic issues that are influenced by (geo)political tensions within the region. The positioning of former Transcaucasian Republics vis á vis this internationalization (e.g. NATO membership) has also been an important factor in conditioning the relations between them.

This conference brings together researchers who study regional issues in Eastern Europe, the Caucasus, Central Asia and the Black Sea. We will therefore discuss a number of issues related to Post-Soviet states and their borders: state-building processes, geopolitical concerns, energy issues, migration, and processes of conflict and cooperation. At this conference we will also debate the role and aims of international actors, including the EU, in promoting cooperation and security.

This conference has been made possible through cooperation between and support from the Georgian Institute of Public Affairs (GIPA), the University of Eastern Finland – VERA Centre for Russian and Border Studies, the University of Warsaw – Centre for European Regional and Local Studies (Euroreg) and Carleton University - Centre for Governance and Public Management. In addition, support for the conference has been provided by the European Union's Seventh Framework Programme for Research and Technological Development and the EUBORDERREGIONS and EUBORDERSCAPES research projects.
